





BRTC's 2 largest fundraising events are the annual Spring Fling and Golf Tournament.


These two events constitute the vast majority of all event giving. Most other Foundation events are lectures and appreciation events.







The Golf Tournament is the Foundation's largest scholarship fundraiser.

Golf Tournament Expenses and Income






16th Annual Spring Fling & Auction




Spring Fling Proceeds








Net Fundraising Totals by Academic Year (July 1 to June 30)






1st year to itemize expenses is FY23

Upon request by Governor Asa Hutchinson, The Armory @ BRTC will be a career and technical center and offer certifications to area high school students who want a high-wage, high-demand job straight out of high school.



Programs to be offered are welding, industrial maintenance/ automation, industrial electricity, and robotics automation focused on distribution and logistics

OSD has invested \$2.383 million for renovations, welding smoke exhaust systems, engineering, installation, a forklift, electrical trainers, instructional supplies, robotic & conveyor equipment.





Other partners are Fidus Global, Hytrol, Greenbrier, the AR Department of Education, , Piggott School District, and the City of Piggott.
